AFOA CANADA TO HOST ITS 16TH NATIONAL CONFERENCE BY INVITING 5 FORMER NATIONAL CHIEFS TO ADDRESS 1,000 ABORIGINAL LEADERS IN MONTRÉAL, QC, FEBRUARY 16-18, 2016

On February 16 - 18, 2016, AFOA Canada is hosting its 16th Annual National Conference, assembling 1,000 of Canada's most prominent Aboriginal business and elected leaders at the Fairmont, The Queen Elizabeth Hotel in Montréal to discuss "*Leadership and Governance – Transformational Change through Education and Capacity Building.*" There are number of change drivers that exist today for Aboriginal Peoples in Canada. These include, but not limited to: a growing and young Aboriginal population; a higher number of Aboriginal students in Colleges and Universities across Canada than ever before; increased resource development on traditional territories; and favorable Supreme Court decisions. For Aboriginal Communities to close the gap between Aboriginal peoples and Canadians and amongst our various Nations across the country, education and capacity building can take communities to the next level in their chosen journey. This conference will focus on the importance of strong leadership and governance.
