BACKGROUND

Established in 2013, the *Indigenous Learning Centre (ILC)* was created as a charity by AFOA Canada, to promote education in finance, management and leadership for Indigenous People's living within Canada. The ILC is pleased to offer assistance to First Nation, Inuit & Métis persons & others wishing to further their career.

The 2018 Professional Development Scholarship Program has received funding support from the NIB Trust Fund to address the impacts of the Indian Residential School System and is consistent with the NIB Trust Funds charitable objects.

APPLICATION DEADLINE: FRIDAY, JUNE 22, 2018

NOTE: Applications that arrive after the deadline date will **NOT** be reviewed.

ELIGIBILITY CRITERIA

The Eligibility Criteria for a Professional Development Scholarship are:

- Applicant **MUST** be a former residential school attendee or a descendant of a residential school attendee
- Employed in a financial and/or management position and/or attending school as a full-time student.
- Reside or work in an Indigenous community/organization.
- Preference will be given to applicants to demonstrate financial need.

AVAILABLE PROFESSIONAL DEVELOPMENT SCHOLARSHIP

The Professional Development Scholarship will be awarded in the following three (3) categories:

#1 – ONLINE COURSES Scholarship – Fifty (50) Scholarships (one scholarship equated one course) are being awarded and available to recipients who wish to take one (Fall or Winter) or two (Fall and Winter) online courses for the Certified Aboriginal Financial Management (CAFM) Program, or the Certified Aboriginal Professional Administrator (CAPA) Program– scholarship value at \$575 each.

#2 - CAPA IN-PERSON SESSION - Ten (10) scholarships are being awarded to recipients who **WILL** enroll in the upcoming National Cohort 9, in Ottawa, ON. National Cohort 9 comprises of six (6) sessions. The scholarship valued at \$7,500 (3 sessions at \$1,500 plus \$3,000 for travel per session), will be awarded to the first three sessions:

- Session 1 - August 11-12, 2018
- Session 2 - October 20-21, 2018

- Session 3 - February 23-24, 2019

#3 - Certified Indigenous Leaders Program (CIL) In-Person Sessions - Ten (10) scholarships are being awarded to recipients who **WILL** enroll in the upcoming National Cohort 1, in Ottawa, ON. National Cohort 1 comprises of four (4) sessions. The scholarship valued at \$7,500 (3 sessions at \$1,500 plus \$3,000 for travel per session), will be awarded to the first three sessions:

- Session 1 - August 11-12, 2018
- Session 2 - October 20-21, 2018

- Session 3 - February 23-24, 2019

Scholarship awards allocated must be used for the program of study and the academic year specified on the application form

#1 - ONLINE COURSE SCHOLARSHIPS

Online Course Scholarships are for candidates who wish to take an online course in the CAFM or CAPA programs. These scholarships will offset one course from the full program or introduce the applicant to the program of their choice. Courses available are as follows:
